


## Federal Funds Account for More Than One-Third of California's State Budget

Total Proposed 2017-18 Expenditures = \$284.5 Billion



## More Than 7 in 10 Federal Dollars Spent Through the State Budget Support Health and Human Services

Federal Funds Projected to Be Spent Through the State Budget in 2017-18 = \$105.0 Billion

## Federal Proposals – Overall Approach and the Threats in 2017

Overall goals and approach: Cut taxes, increase defense spending, reduce "non-defense discretionary" spending.


- Repealing the Affordable Care Act (ACA), including Medicaid (Medi-Cal), with no real replacement
- Dismantling the current safety net through block grants and caps on Medicaid and SNAP (food assistance)
- Deep federal budget cuts to other discretionary program and entitlements
- Major federal tax cuts as "tax reform"

## Federal Proposals – Biggest Threats to Children and Children's Health

- Repealing the Affordable Care Act (ACA), including Medicaid (Medi-Cal), with no real replacement
- Dismantling the current safety net through block grants and caps on Medicaid and SNAP (food assistance)
- Deep federal budget cuts to other discretionary programs and entitlements
  - Education cuts and neo-vouchers expansion
- Other major concerns: CHIP Reauthorization

## The Share of Residents Enrolled in Medi-Cal Exceeds 40 Percent in 20 Out of 58 Counties


Medi-Cal Enrollees as a Percentage of the Population, January 2016

## Underlying budget strategies to watch for in current and future debates

- Block grants and per capita caps
  - Cap the total available federal funds.
  - Not usually adjusted for inflation and demographic changes; more likely to be cut than increased.
- Cutting federal spending and shifting costs to states
  - Potential threat for SNAP and CHIP.
  - Forces states to cut funding and restrict eligibility.
- Restricting eligibility for certain populations (a particular threat for immigrant children).
- Regulatory uncertainty and interference...

#### Federal Timelines and Uncertainty Leading Up to Fiscal Year 2018 (Oct. 1)

- ACA
  - House approved 2017 reconciliation bill to repeal ACA.
  - Senate fails on 2017 reconciliation bill to repeal ACA.
- Federal Budget
  - Congress adopts/extends FY 2017 appropriations.
  - President releases proposed FY 2018 budget
  - Congress has not yet adopted FY 2018 budget resolutions or started appropriations process.
- Federal Tax and Debt Issues
  - President released "skinny" tax reform proposal
  - Congress has to raise the federal debt ceiling by 9/29

# Key issues to watch in August and September

- Congress has 12 working days left in FY 2017
- A FY 2018 budget must be passed to avoid a government shutdown – most likely scenario is a "continuing resolution" (CR).
- The debt ceiling must be raised by 9/29 according to the U.S. Treasury – will likely require a bipartisan vote.
- Federal tax "reform" is unlikely but we may see efforts to pass a budget and tax package that cuts taxes on corporations and higher-income individuals.
